# EXPRESSION OF INTEREST FOR CPD PLATFORM

Digitization allows for on-demand access and promotes level of uniformity and quality control.

This will ensure that the entire process of online accredited education and grant of credit points is completely within the end to end regulated control of MMC and accreditation data is protected and not shared with any privately owned third party.

Technical Specifications for Webinars for RMPs for CPD:

#### 1. Webinar Platform:

- Develop and provide a robust webinar platform for online interactive education and medical content delivery.
- Support access through PCs and mobile devices.
- Ensure at least one operational instance of the platform in India.
- Enable real-time participation and engagement of RMPs during webinars.

#### 2. Content Management:

- Provide a user-friendly interface for MMC's medical experts/ editors to create, edit, publish and update webinar content without technical expertise.
- Facilitate easy management of multimedia presentations, documents and resources.

#### 3. Platform Customization:

- Allow customization of platform structure, including site navigation, course ordering, pass percentages and module-level access rights.
- Enable flexibility for MMC to adapt the platform to specific requirements and future needs.

## 4. Ownership and Licensing:

- Grant MMC full ownership and licensing rights to the platform.
- Allow sublicensing to government-owned or charitable organizations without restrictions.
- Ensure no private company branding, instead branded as "MMC Accredited Medical Education Platform."
- -Permit sub-licensees to brand the platform under their own names.

#### 5. Content Rights and Data Usage:

- Solution provider should not have content rights, distribution rights or data usage rights for published content unless a medical university, medical college or medical association that owns the content.

- 6. Data Privacy and Security:
- Host the platform on MMC servers and obtain written permission for any data or content transfer to third-party servers, except in exceptional circumstances.
- Implement advanced data encryption, audit logs, two-factor authentication and other security features.
- Prohibit access rights to external parties without MMC's explicit authorization.

## 7. Managed Services Provider:

- Allow MMC to change the managed services provider at any time.

#### 8. Confidentiality:

-The Solution Provider may be required to sign a non- disclosure or confidentiality agreement.

#### 9. Modularity and Expandability:

- Design the platform to be modular, allowing seamless integration of third-party technologies in the future (e.g., face recognition, security systems, video and voice interfaces, AI tools).

#### 10. Monitoring Dashboard:

- Include a comprehensive monitoring dashboard with restricted access to MMC personnel for various reports at different levels.

#### 11. Training and Platform Management:

- Provide detailed training to MMC staff for independent platform management.
- Include documentation and support resources.

## 12. Live Streaming and Webinar Recording:
